PREREQUISITES FOR FREESHIPS UNDER SPORTS QUOTA

The College has decided to provide freeships of 50 % fee consession to all Sports Students of various courses i.e BBA, BCA, B.Com, B.Sc, MBA, M.Sc(CS) in the College who are not availing Government scholarship/NGO's under Sports Quota.

A Standard procedure is followed by the College regarding the same:

- The Student who intend to avail the facility have to submit their application in a prescribed format to the office.
- The Students must be a National Sports Representative or State level Sports representative to avail this Scheme.
- 50% of Fee Concession will be given as freeships to Sports students under Sports Quota Scheme.

PREREQUISITES FOR FREESHIPS UNDER ACADEMIC MERIT

The College has decided to provide freeships of 10 % fee consession to all Merit Students of various courses i.e BBA, BCA, B.Com, B.Sc, MBA, M.Sc(CS) in the College who are not availing Government scholarship/NGO's under Sports Quota.

A Standard procedure is followed by the College regarding the same:

- The Student who intend to avail the facility have to submit their markslist to the office.
- The Students must have 90% marks in their academics.
- 10% of Fee Concession will be given as freeships to Merit sudents under Acdemic Merit Scheme.
